6 Age limit : 19-36. Only candidates born between 02.01.1980 and 01.01.1997 (both dates included) are eligible to apply for this post with usual relaxation to Scheduled Castes, Scheduled Tribes and Other Backward Communities

7 Qualifications:- Graduation with either Mathematics or Biology as one of the optional subjects for Pre-degree course

Note:- Rule 10(a)ii of Part II of KS&SSR is applicable

- Training:- Every candidate selected for appointment as Dairy Farm Instructor shall undergo eight months training before they are appointed regularly. The training shall be imparted by the Dairy Development Department. They shall be paid the minimum of the basic pay of Dairy Farm Instructor per mensum as consolidated allowance during the period of training . The period of training shall not be counted for probation and increment.
- Probation:- Every Person appointed to the post shall from the date on which he joins duty, be on probation for a total period of two years on duty within a continuous period of three years.

### 8. Mode of submitting applications :-

Candidates shall register as per 'ONE TIME REGISTRATION ' system on the Official Website of Kerala Public Service Commission 'www.keralapsc.gov.in' for applying for the post. Candidates who have registered shall apply by logging in to their profile using their User- ID and password.
