**5 Method of Appointment**: Direct Recruitment (Special Recruitment from among Scheduled Castes/Scheduled Tribes).

Note:- Applications received from candidates other than Scheduled Caste/Scheduled Tribe candidates will be rejected. Individual communications regarding the rejection of their applications for the above reason will not be issued.

**6 Age** : 19 - 49

Only Candidates born between 02.01.1967 and 01.01.1997 (both dates included) are eligible to apply for this post. No other age relaxation will be allowed.

Note:- In the absence of qualified candidates within the age limit the upper age limit shall be relaxed up to 50 years. But in no case the maximum age limit shall exceed 50 (Fifty) years.

## 7 Qualifications:

- (1) Pass in SSLC or its equivalent qualification.
- (2) (a) National Trade Certificate in the appropriate Trade

(b) National Apprenticeship Certificate in the appropriate trade

(c) Diploma in the appropriate branch of Engineering from a Government or Government recognised Polytechnic or its equivalent examination.

## 8 <u>Training:</u>

Only those who have successfully completed training from Central Institute shall be eligible for promotion. However the eligibility of those who have not been deputed for training by Government for no fault of theirs will not be affected if they are otherwise qualified for promotion but such persons should undergo training after promotion.
