**THIRD NCA NOTIFICATION**

Applications are invited online only from qualified candidates belonging to reservation group of OX community in the State of Kerala against NCA vacancies for selection to the under mentioned post in Kerala Government service. Before applying for the post the candidates shall register as per the One Time Registration scheme through the official website of Kerala Public Service Commission. This is the third NCA Notification issued due to the non-availability of candidates for the post as per notifications dated 30.11.2009 (Cat. No.430/2009) and 31.12.2013 (Cat. No.579/2013).

1. **Department** : Kerala Vocational Higher Secondary Education
2. **Name of Post** : Vocational Teacher-Livestock management
3. **Scale of Pay** : ₹ 39500-83000/-
4. **Number of vacancies** : 1 (One) ( OX )

The above vacancy is now in existence. The ranked List published as per this notification will be valid until candidates are advised and appointed against the above vacancy earmarked for OX community, but remain unfilled due to the paucity of candidates during the currency of the Ranked List published on 17.04.2007 for the post.

5. **Method of appointment** : Direct Recruitment (From candidates belonging to OX community only).  
Applications submitted by candidates other than OX community will be summarily rejected. No rejection memo will be issued to these candidates
6. **Age limit** : 23-43, only candidates born between 02.01.1973 and 01.01.1993 (both dates included) are eligible to apply for the post.(Including the relaxations as per para 2(i) of general conditions.)

( For conditions regarding age relaxation please See Para 2 of the General Conditions except para 2(i))

**Note:-** In case of adult members of Scheduled Caste converted to Christian religion and their Children, the Upper age limit shall be 45 years. i.e. candidates born between 02.01.1971 and 01.01.1993 (both dates included)

**7. Qualifications:-**

Degree in Veterinary Science and Animal Husbandry with not less than 60% marks from Kerala Agricultural University or an equivalent qualification.

Note :- (i) In the appointment of Vocational Teacher preference will be given to persons having additional qualification of Diploma in Computer Application from a recognized institution.

(ii) All the Educational Qualifications for teaching posts should be one acquired after a regular course of study from a recognised University in Kerala or recognized as equivalent thereto by any of the Universities in Kerala.

**Note:-** *KS&SSR Part II Rule 10(a)ii is applicable.*

**8. Mode of submitting Application: -**

(a) Candidates must register as per 'ONE TIME REGISTRATION' with the official Website of Kerala Public Service Commission '[www.keralapsc.gov.in](http://www.keralapsc.gov.in)' before applying for the post. Candidates who have registered can apply by logging in to their profile using their User-ID and password. Candidates must click on the '**Apply Now**' button of the respective posts in the Notification Link to applying for a post. The Photograph uploaded should be one taken after 31.12.2010. Name of the candidate and the date of taking photograph should be printed at the bottom portion. The photograph once uploaded meeting all requirements shall valid for 10 years from the date of uploading. There is no change in other instructions regarding the uploading of photographs. No application fee is required. Candidates shall take a printout of the application by clicking the link **Registration Card** in their profile. Candidates are responsible for the correctness of the personal information and secrecy of password. Before the final submission of the application candidates must ensure correctness of the information on their profile. They must quote the User-ID for further communication with the Commission. Application submitted is provisional and cannot be deleted or altered after submission. The application will be summarily rejected if noncompliance with the notification is found in due course of processing. Documents to prove qualification, Experience, Community, age etc. have to be produced as and when called for. **Candidates who have AADHAAR card should add AADHAAR card as I.D. Proof in their profile.**

(b) If a Written/OMR Test is conducted as part of this selection, Admission Ticket for eligible candidates will be made available in their Profile for One Time Registration and the date of downloading will be included in the Examination Calendar. Candidates can download Admission Ticket for 15 days from this date. Candidates who have downloaded the Admission Ticket will alone be permitted to attend the examination.
